



Section 1: Considerations for Remote Administration of Interim Assessments

This document outlines considerations, guidance, and processes that schools and complex area staff should discuss regarding the remote administration of the Smarter Balanced and HSA Science (NGSS) Interim Assessments.

The Smarter Balanced and HSA Science (NGSS) Interim Assessments will be available for in-person or remote administration in SY 2021-2022. Remote administration of the interim assessments, including the Smarter Balanced Interim Assessment Blocks (IABs), Focused Interim Assessment Blocks (FIABS), and the Interim Comprehensive Assessments (ICAs) will be made available without students needing to use the secure browser. Cambium Assessment (CAI) and the Hawai'i Department of Education (HIDOE) Assessment Section have developed this document, *Guide to Remotely Administering Interim Assessments*, to provide specific guidance on administering interim assessments remotely.

The HIDOE believes data from remote interim administration should only be used for teachers' instructional decision-making. **Data should not be used for any other purpose, including but not limited to the placement of students in classes, the identification of student performance trends, or as a replacement for summative test results. Interim assessments are not designed nor should they be used for accountability purposes, e.g., grading.**

Below are some thoughts for complex area and school staff to consider regarding the administration of interim assessments.

Equity

- Equitable access must be provided to all students if interims are administered remotely. Be mindful that students who require assistive technology may not be able to interact with the interims fully if they do not have the appropriate assistive technology (such as a Braille embosser) available at home. Certain supports, such as print-on-demand, will likewise not be feasible to provide.
- If equitable access is not possible, the HIDOE recommends the ***Alternate Use of Interim Items*** provided on page 2 in order to maintain compliance with students' IEP or 504 plan and learning needs.

Security

- Interims are considered "student- and teacher-facing" so only the students in a teacher's class and the teacher should have access to interim assessments or items.
- All Interims are fixed-form tests, which means that all students taking an interim assessment will see the same items in the same order. Exposure to and familiarity with test items may affect student performance and the accuracy of interim results as an indicator of student's knowledge and skills. Therefore, schools must ensure that the assessments stay within the classroom and learning environments. Additionally, interim assessments are not for public use, display, or distribution and must not be copied into third party systems (e.g., Google Docs). Access to individuals beyond authorized school staff and students is prohibited.
- To take an interim assessment remotely, students will need to have their SSID number. Each student's SSID should be treated as securely as one's social security number. Student SSIDs must not be

distributed en masse to all students and families. Mass sharing of student information—including SSID numbers—is a FERPA violation. A student’s SSID needs to be provided only to the student or an appropriate family member via a phone call or through secure means such as a complex area’s or school’s password-enabled parent portal or other school or complex area secure tool.

Administration

- The administration of interims requires the students and teacher to be online at the same time.
- Smarter Balanced has developed the [Tools for Teachers Remote Teaching and Learning website](#) that describes allowable uses, guidance, security, and considerations for interim assessments and items. The HIDOE asks that school and complex area staff attend to the guidance on that webpage when considering the use of interims. This guidance also applies to the HSA Science (NGSS) interim assessments.
- That website also provides information on other Smarter Balanced resources that can be used during remote teaching and learning. The HIDOE encourages schools and complex areas to consider how those other resources—many of them publicly available—could be used as well.

Alternate Use of Interim Items

If the standardized remote administration of interims (i.e., administering interims as a test) does not fit well with a school’s or complex area’s remote learning model, educators may use items from any interim assessment in a non-standardized way by accessing the Assessment Viewing Application (AVA) for NGSS or for ELA/L and math, the Interim Assessment Item Portal (IAIP) within Tools for Teachers, available on the [Hawai‘i Statewide Assessment Program Portal](#) for authorized users. Please follow the guidance and security considerations provided on the [Tools for Teachers Remote Teaching and Learning website](#) when using AVA or the IAIP.

Section 2: Administering Interim Assessments Remotely

HIDOE supports teaching and learning by allowing teachers to remotely administer the Smarter Balanced IABs, FIABs, and ICAs, as well as the HSA Science (NGSS) Interim Assessments. Cambium Assessment has configured the Test Delivery System to assist in this effort. Students may access the interim assessments remotely using Chrome or Firefox web browsers. This document describes how Test Administrators (TAs) can remotely administer the interim assessments and how students can take an interim assessment.

Interims may be remotely administered in SY 2021-2022.

How Test Administrators Administer Interim Assessments Remotely

Test Administrators will remotely administer interim assessments the same way they would at their schools. Test Administrators will need to communicate with students to provide a session ID and to provide support for students through the login process, including helping them securely find their student ID. **It is important that the session ID and student ID are communicated using a secure method, such as a classroom management system. Sending secure student information—including their student ID—via a non-secure method is a FERPA violation.** Test Administrators should carefully monitor the time students are working to complete an interim.

Guidelines for Administering Interim Assessments During Remote Instruction

- An authorized Test Administrator, who has completed the TA certification course, in a school administers the interim consistent with HIDOE and school policies for in-person interim assessment administration.
- The TA monitors the interim activity such that interims are open only for the minimum amount of time necessary for students to complete and submit their responses.
- The TA uses established test administration practices to support students accessing the interim assessments; this may be a phone call or chat with a parent in advance of starting the test.
- The TA maintains student data privacy with student ID and other personally identifiable information (PII), which are required to take an interim.
- The TA follows HIDOE test security procedures and immediately escalates to the Test Coordinator any suspected item security issue (e.g., posting interim items on social media). In the case of any breach, where an item may have been shared publicly, the School Test Coordinator is responsible for notifying the HIDOE Assessment Section at (808) 307-3636.

Administering an Interim Assessment Session

1. In order to administer a test through the TA Live Site, a test administrator should be Identified in TIDE as a TA and have completed the TA certification course.
2. Navigate to the [Hawai'i Statewide Assessment Program Portal](#) and log in to the TA Live Site using your TIDE username and password.
3. Select the interim assessment you will be administering.
4. Start the test session and securely provide your students the session ID that is generated. This session ID will be used by all students for the session, but when this session is closed a new session ID will be required.

5. After your students sign in and select the interim, approve them into the session so that they may start testing.
6. After all students complete the interim, stop the test session and log out.

Providing Information to Students and Families

The information and directions on the next pages can be provided to students and families as is, can be modified by school staff for students and families, or can be used by schools to create a different communication for students and families.

Signing in to Take an Interim Assessment

Once students have the required software browser as outlined above, they are ready to sign in and take an interim assessment.

1. Launch the required software browser.
2. In the URL bar, enter <https://mobile.tds.cambiumast.com/Launchpad> and hit enter on your keyboard. The **Mobile Launchpad** page appears.
